

**East Ayrshire Council**  
**(Grassyards Road, Kay Park Crescent, Kay Park Terrace,**  
**MacKenzie Drive and MacNeil Place, Kilmarnock)**  
**(Temporary Prohibition of Waiting) Order 2022**

On 01/02/22 the Council, in exercise of the powers conferred on it by Section 14(1) of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (East Ayrshire Council) Designation Order 2012, and the Road Traffic Act 1991, as amended, and of all other enabling powers, made the above-named Order, which will make it unlawful for any vehicle to wait on the following lengths of road at any time by reason of works to be executed on or near the road.

Grassyards Road – East Side - From a point 10 meters north of the extended northern kerbline of MacKenzie Drive southwards for 28 meters

Kay Park Crescent (North/South Leg)– Both sides - From a point 14 metres north of the extended northern kerbline of Kay Park Crescent (east/west leg) southwards for 36 metres

Kay Park Crescent (East/West leg) -North side - From the junction with Grassyards Road westwards for 35 metres

Kay Park Crescent (East/West leg) - South side - From its junction with Grassyards Road westwards for 18 metres

Kay Park Terrace -The perimeter of the eastern road head, on all sides between a point 12 meters west of the property boundary line between no No.19 Kay Park Terrace and No.5 Grassyards Road and the eastern extent of the road.

MacKenzie Drive – Both Sides -From its junction with Grassyards Road eastwards for 12 metres and From a point 10 metres southeast of the extended eastern kerbline of MacNeil Place north-westwards for 35 metres

MacNeil Place – Both sides - From its junction with MacKenzie Drive north-eastwards for 14 metres

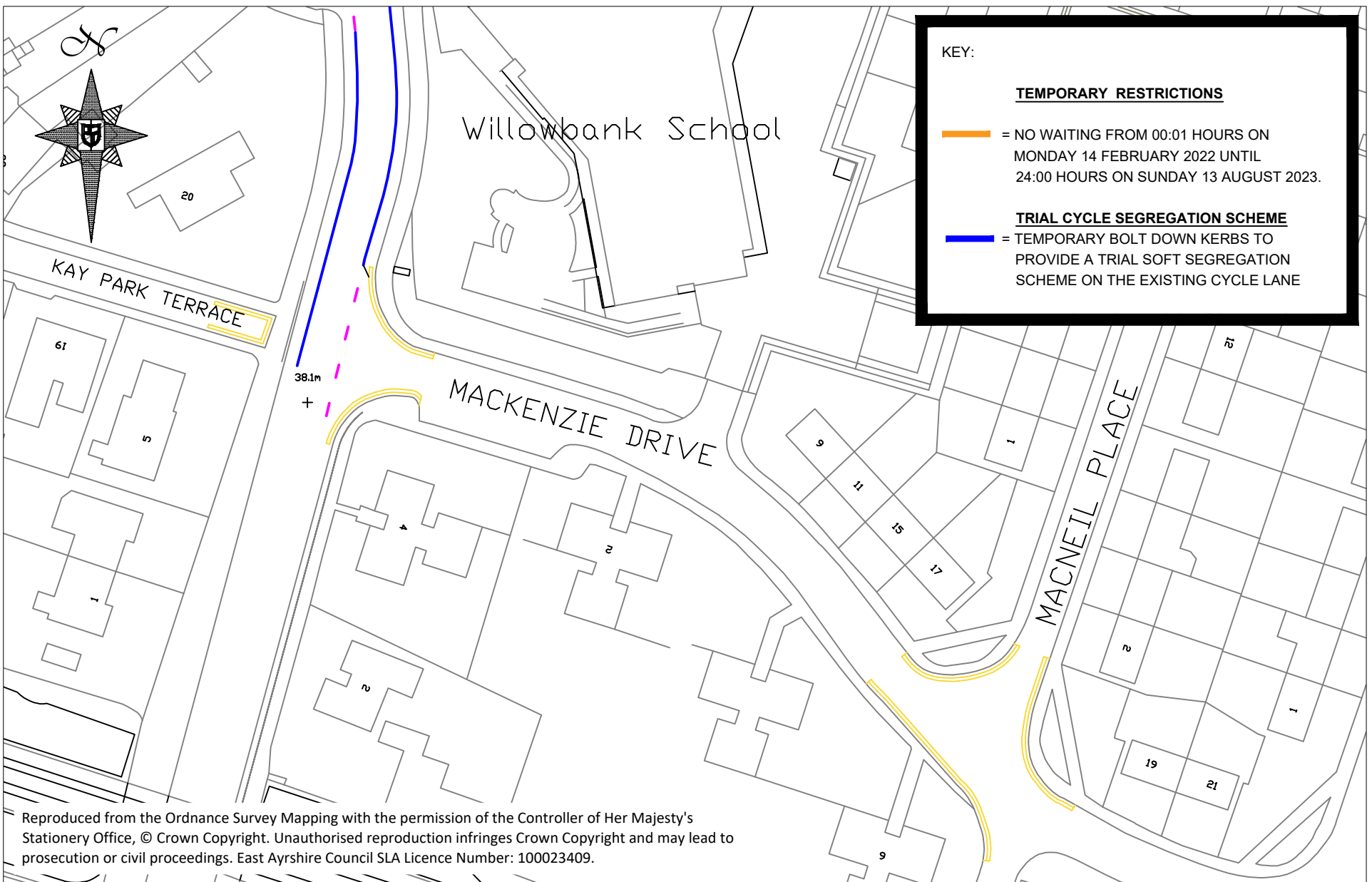
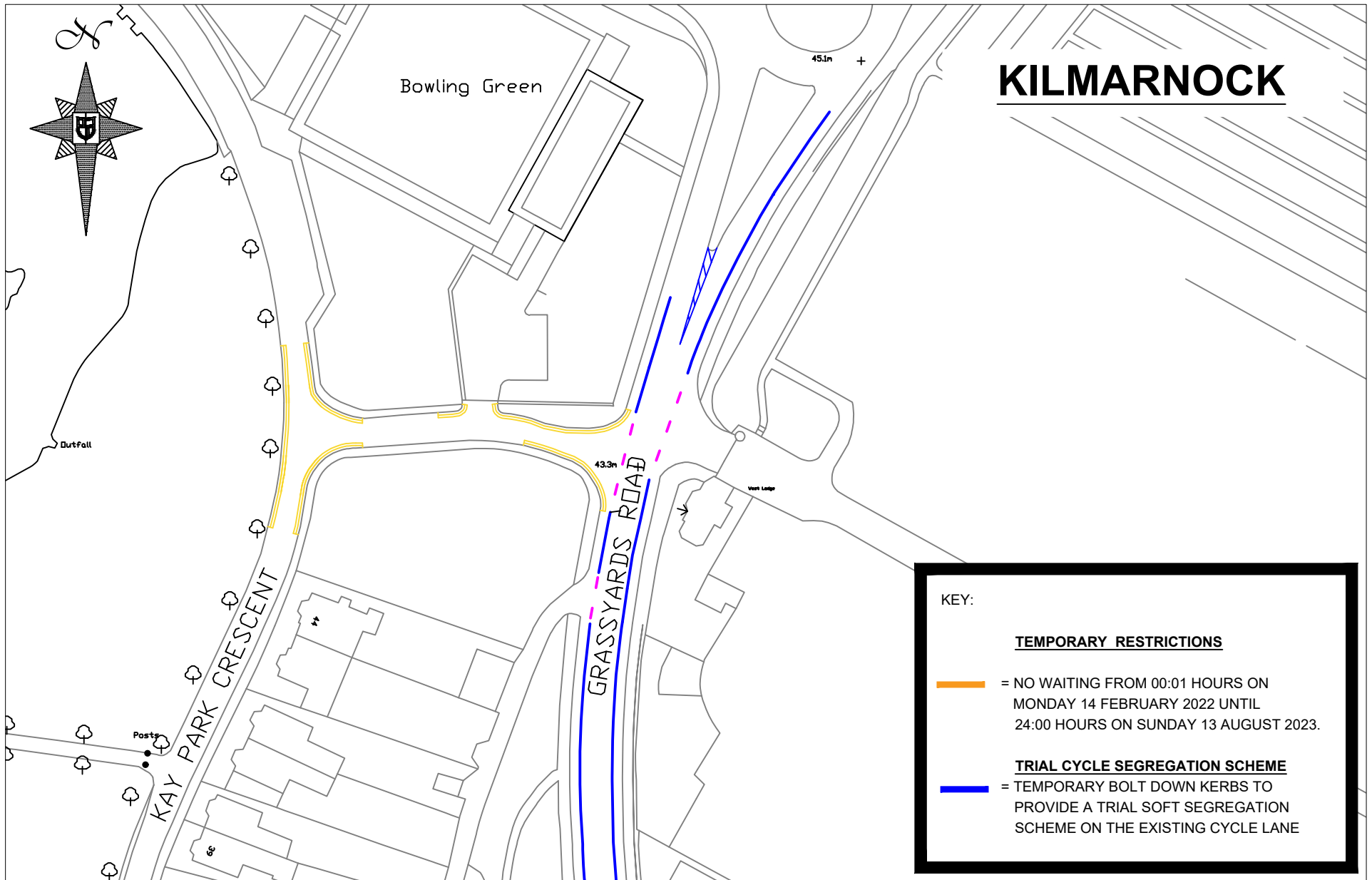
