

INTRODUCTION

Gatehead is one of the smallest villages in East Ayrshire with 146 dwellings falling within its boundary, including several outlying farms and rural houses. It is situated on the A759 between Kilmarnock and Dundonald with the area bounded on one side by the River Irvine neighbouring both North and South Ayrshire.

The community of Gatehead, although a fairly small village; has a strong community spirit and large ambitions to help make their community a better place to live, work and visit. Priorities on what the community would like to see happen have been gathered through the Community Action Plan engagement process. Community Action Plans (CAP) are 5 year plans which are led by communities looking to take on actions identified and voted on by their community. This then shapes actions to be taken forward in improving their community. The process is facilitated by East Ayrshire Council's Vibrant Communities, with it being led by the communities developing the plan. The Steering Group was formed off the back of interested representatives of Gatehead Bridge Project, Gatehead Community Council and individuals.

A Community Action Plan seeks to engage a community in identifying priorities for their area and to stimulate the community into making those priorities happen. The plan is not a shopping list for things we want done. This plan is a vision for how we want Gatehead to be. It's up to us as a local community, working alongside others, to get involved and make things happen.

Gatehead Community Action Plan 2024-2029 has been compiled reflecting the aspirations of the community of Gatehead through different consultation methods during 2021-2023. These methods included household surveys, online surveys and stakeholder interviews. We also held informal consultation events and group meetings in the Village Hall.

The household surveys were sent to all 146 houses within the Gatehead Community Council boundary, of which 56 responses were returned. We also engaged with the children and young people in the village through meetings in the school gathering their thoughts on what they liked, did not like and would like to see happen in Gatehead. A further 19 responses were gathered here, taking the total of 75 responses. This means there was a return rate of 51% response from the community throughout the demographic.

OUR COMMUNITY


Gatehead can be traced back as far as middle to late 1700's and was likely established as a collier's village in support of the coal mines in the area. The mine heads have long since been capped and the miner's rows that existed near the Old Rome Farmhouse now demolished, but the schoolhouse is still in existence and has been converted into two private dwellings. The Cochrane Inn is likely to have been established as a coaching house to provide a service to travellers journeying through the area.

The village is split by the Kilmarnock to Troon railway line, which was opened in 1811, with the level crossing still a well-known landmark. A station also existed at this time but closed in 1967. The remains of the station platform can still be seen.

Laigh Milton viaduct lies within the boundary and was erected to allow the railway to cross the River Irvine. The viaduct is of historical significance as it is reputed to be the oldest existing railway viaduct in the world. The railway was established predominantly to move coal from Kilmarnock to the harbour at Troon, but was also carrying passengers soon after it's opening in 1811. The viaduct had fallen into a state of disrepair but has recently been refurbished at considerable expense. The railway does not cross here anymore, with a new bridge built further south along the river. However, tourist access can be gained via a riverside path starting at Laigh Milton Mill.

In regards to population, from the 2011 Scottish Census data, Gatehead's population was sitting at 338. For the 2021 census, population is expected to remain steady as there has been very little housing or opportunity development within the area. However more detail on this census is to be released in 2024.

The village of Gatehead holds a lot of heritage and history given its location within Ayrshire and its industrial links. There used to be a post office and shop within the village, however this has since closed down and has left villagers requiring to travel to neighbouring towns for amenities. There is no primary school, doctors surgery, dentist or retail opportunity. The Cochrane Inn has offered economic and tourism benefit and the community are supportive in it's re establishment following temporary closure.





"Get a shop for the village"


"I would like to see the river cleaned up and properly maintained. Organisations need to take responsibility for it to retain this asset to the village"

LOCAL PLACE PLAN

Local place plans are community-led proposals for land development and use in a specific area, aimed at influencing the future of the community. These plans are prepared by community bodies and include a vision, map, and action plan for the area. They should align with national and local policies and outcomes, reflecting the views and needs of the local community. The council's planning authority must consider the local place plan when preparing or reviewing the local development plan, which guides planning decisions in the area. The aim is to enhance engagement in development planning, empowering communities to play a proactive role in defining the future of their places. Local place plans are an expression of community aspirations and solutions that can influence local planning policy, setting priorities for future development and helping communities develop and deliver their own projects. They are introduced by the Planning (Scotland) Act 2019, granting communities the right to produce their own plans as part of the new Scottish planning system.

Gatehead have started the process of developing a Local Place Plan for their community. As part of the survey collation and consultation phase, data has been gathered around the community's views around Place and vision for the future for Planning matters in their area. A specific question was asked around how to make Gatehead more green, eco-friendly or sustainable community. The feedback from this will be used in progressing a Local Place Plan incorporating the Place Standard Tool for the community which will fall inline with the Local Planning Policy for East Ayrshire.
