- 1. This Order may be cited as the temporary stopping up of footpath (Northcraigs, Kilmarnock) Order 2023 and shall come into operation on 28 April 2023.
- 2. In this Order:
 - "footpath" means the length of footpath in East Ayrshire that is specified in the Schedule of this Order.
- 3. The temporary stopping up of the footpath is hereby authorised.
- 4. Where, immediately before the date of this Order, there are any rights of statutory undertakers in respect of any apparatus of theirs which is under, in, on, over, along or across the road, such undertakers shall thereafter, without prejudice to the provision of Sections 224 and 225 of the Town and Country Planning (Scotland) Act 1997 have the same rights in respect of that apparatus as they had immediately before that date.

As indicated on the attached plan, the total length of the footpath to be temporarily stopped up at Northcraigs, Kilmarnock is:


